



ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF YSEEK, INC.

TO: Department of State Tallahassee FL 32304

Pursuant to the provisions in Section 607.1003 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on May 2, 2003, and continued until May 12, 2003:

1. The following amendment to the Articles of Incorporation of Yseek, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on May 12, 2003, in the manner prescribed by the Florida General Corporation Act:

ARTICLE I NAME

The name of the corporation shall be Advanced 3-D Ultrasound Services, Inc. and its principal office and mailing address shall be 7732 N. Mobley Drive, Odessa, Florida 33556.

- 2. The number of shares of the corporation outstanding at the time of such adoption was 36,011,765 shares common stock; and the number of shares entitled to vote thereon was 36,011,765 shares common stock.
