**ARTICLE I - NAME**

The name of this corporation is ADULT THINGS, INC. and its principal place of business is 7600 Old Plank Road #70, Jacksonville, Florida 32220.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing upon the filing of these articles of incorporation with the Secretary of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - STOCK**

This corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock.

#### ARTICLE V - PREEMPTIVE RIGHTS
