**Articles of Incorporation
of

ARTICLE I - NAME

The name and address of this corporation is: **JoVal's International, Inc., 5215 N.W. 75th Avenue, Lauderhill, Florida 33319.**

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1000) shares of one dollar (\$1.00) par value common stock.
