## **ARTICLES OF INCORPORATION**

#### **ARTICLE 1 - NAME**

The Name of the corporation shall be: LIBBY'S ITALIAN EATERY, INC.

#### **ARTICLE 2 - DURATION**

This corporation shall exist in perpetuity.

#### **ARTICLE 3 - PURPOSE**

General nature of the business and the object and purposes proposed to be transacted and carried on, are to do any and all of the things mentioned herein, as fully and to the same extent as natural personas might or cud, viz: Engage in any business or activity permitted under the laws of the United States and the State of Florida, including but not to the following:

a) To take, acquire, buy, hold, own, maintain, work develop, sell, convey, lease, mortgage, exchange, improve and otherwise invest in and dispose of real estate and real property or any interest or rights therein without limit as to the amount; to do all things and engage in all activities accessary and proper or incidental to the business

of investing in and developing real estate.

b) To sell at wholesale and rotail and to deal in any manner whatsoever in all types and descriptions of property; to do all things and engage in all activities necessary and proper incidental to the business of investing in and developing real estate.

- c) To conduct and carry on the business of builders and contractors for the purpose of building, execting, altering, repairing or doing any other work in connection with any and all classes of building and improvements of any kind and asture, whatsoever, including the building, abuilding, alteration, repairing or improvement of houses, factories, buildings, works or erections of every kind and description whatsoever, including the location, laying out and constructing of roads, avanues, docks, alips, sovers, bridges, wells, wells, canals, railroads or street railways, power plants and generally in all classes of building erections and works, both public and private, or integral parts thereof, and generally to do and perform any and all works as builders and contractors, and with that end in view to solicit, obtain, make, perform and carry out contracts covering the building and contracting business and the work connected therewith.
- d) To manufacture, buy, sell, trade, and deal in all and every kind of material product, manufactured and unanasufactured, iron, steel, wood, brick, coment, granite, stone and other products and materials, including the quarrying of stone, to buy, acquire, hold, use, employ, mortgage, convey, lesse, and dispose of patent rights, letter,

patent processes, devices, inventions, trademarks, formulas, goodwill, and other rights; to advances from time to time on bonds secured by mortgage for future advances on real estate, but nothing herein set forth shall give or be construed to give said corporation any banking powers.

- c) To purchase, take and lease, or in exchange, hire or otherwise acquire any real or personal property, rights or privileges suitable or convenient for any of the purposes of this business, and to purchase, acquire, erect and construct, make improvement of building or machinery, stores or works, insofar as the same may be appurtenant to or useful for the conduct of the business as above specified, but only to the extent to which the commany may be authorized by the statutes under which it is organized.
- f) To borrow or raise money for any purpose of the company, and to secure the same and interest, or for any other purpose, to mortgage all or any part of the property corporeal or incorporeal rights or franchises of this company now owned or hereafter acquired, and to create, issue, draw and accept and negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.
- g) To buy, sell, and generally trade in store, carry and transport all kinds of goods, wares, enerchandise, provisions and supplies.

#### **ARTICLE 4 - CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of One Dollar (\$1,00) par value common stock.

#### **ARTICLE 5 - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for each of my new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE 6 - INITIAL REGISTERED OFFICE AND AGENT

The approval of the chareholders of this corporation to any plan of morger shall be required in every case, whether or not such approval is required by law.

#### ARTICLE 13 - INDEMNIFICATION

The corporation shall inclausify and officer or director, or any former officer or director, to the fall extent possitted by law.

#### ARTICLE 14 - AMENDMENT

This corporation reserves the right to amend or separal any provision contained in these articles of incorporation, or any assentances hereto, and any right confirmed upon the shareholders is subject to this reservation.
