# ARTICLES OF INCORPORATION

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE ONE

The name of the corporation is: ATTORNEY ALTERNATIVES, INC. The principle address of the corporation is: 332 W. Boynton Beach Blvd., Ste. #6, Boynton Beach, FL 33435.

#### **ARTICLE TWO**
