ARTICLES OF INCORPORATION

OF

INTEGRITY FIRST INSURANCE CORPORATION

The undersigned, acting as incorporators of INTEGRITY FIRST INSURANCE CORPORATION, adopt the following Articles of Incorporation to form a stock insurer corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: INTEGRITY FIRST INSURANCE CORPORATION

ARTICLE II. ADDRESS

The principal place of business of the corporation is in Palm Beach County at the following address:

ARTICLE III. COMMENCEMENT & TERM OF EXISTENCE

The existence of the corporation will commence at 12:01 A.M. on the date of filing these Articles of Incorporation and shall exist perpetually.

ARTICLE IV. NATURE OF BUSINESS

The purpose of the corporation is to engage in the following business activities:

- 1. Engage in every aspect of property and casualty insurance as specifically defined in Sections 624.604, 624.605 and 624.606 of the Florida Statutes for the following lines of insurance:
 - a) Homeowners Multi Peril
- 2. Any other lawful activity permitted to be conducted by insurance companies under the laws of the State of Florida.

ARTICLE V. CAPITAL STOCK

The maximum number of shares that the corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$1.00 per share. The corporation shall not begin transacting business unless it achieves a capital and surplus of Five Million and No/100 (\$5,000,000) Dollars.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 12794 Forest Hill Boulevard, Suite 34, Wellington, Florida 33414, and the name of the corporation's initial registered agent at that address is ROBERT E. JOHNSON, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open to receive service of process from the Treasurer and Insurance Commissioner of the State of Florida.

ARTICLE VII. BOARD OF DIRECTORS

The corporation shall have five (5) directors initially, whose term of office shall not be for more than one (1) year after the date of incorporation, all of whom are United States citizens and all of whom are over the age of 18. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than five.
