The undersigned natural person, having capacity to contract and acting as the Incorporator of this Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for such Corporation, to-wit:

ARTICLE ONE: NAME AND PRINCIPAL OFFICE

The name of the corporation is: SYSTEM CLEANING CORP. The address of its principal office is: 12293 Riverfalls Court, Boca Raton, Florida 33428.

ARTICLE TWO: COMMENCEMENT AND DURATION

The Corporation is to commence its existence September 24, 1997, and will exist perpetually thereafter unless earlier dissolved in the manner prescribed by law.
