#### ARTICLES OF INCORPORATION

OF

#### BARNUM'S PAINTING AND DRYWALL, INC.

#### ARTICLE I - NAME:

The name of this corporation is: BARNUM'S PAINTING AND DRYWALL, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
