ARTICLES OF INCORPORATION

OF

ALLIED CONSULTANTS, INC.

ARTICLE ONE

The name of this corporation is ALLIED CONSULTANTS, INC. and the mailing address of the corporation shall be 2222 Second Street, Fort Myers, FL 33901.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

The duration of the corporation is perpetual.
