The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

### **ARTICLE I**

### NAME

The name of the corporation is **OPERATIONS SOLUTIONS CORPORATION**, and its address is 1674 Meridian Avenue, Suite 204, Miami Beach, Florida 33139.

# **ARTICLE II**

### DURATION

The duration of the corporation is perpetual.
