The undersigned subscriber to these articles of incorporation, being duly licensed to practice occupational therapy under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

**ARTICLE I  
CORPORATION NAME**


