# ARTICLES OF INCORPORATION

ARTICLE I. NAME

SECRETARY OF STATE TALLAHAS SEE, FLORIDA

The name of this corporation shall be ENDLESS PALMS INC.

# ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Secretary of the Department of State, Division of Corporations. This corporation's duration shall be perpetual.

# ARTICLE III. PURPOSE

This corporation is being organized for the purpose of providing professional services for Income Tax Prepartion, Title Insurance and various other business activities permitted under the laws of Florida and the United States Of America.

### ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 1000 shares of common stock at no par value.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.

Each stock certificate issued by this corporation shall carry the following legend:
