NAME

The name of this corporation is: Southeast Keyboards Investments, Inc.

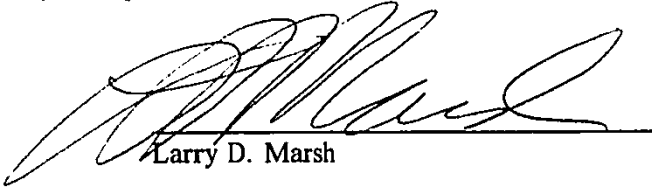

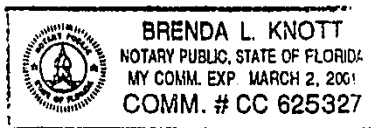

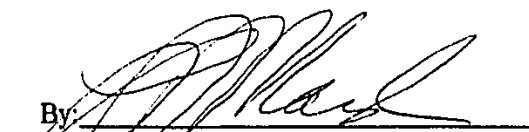
