RE: Annual Reports Filing

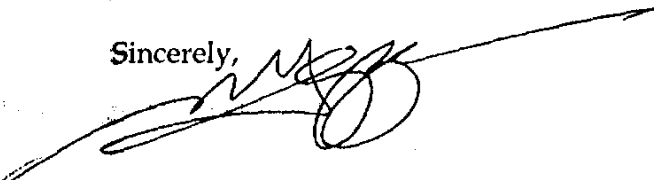
