## ARTICLES OF CORPORATION

OF

## ARTICLE I - NAME

The name of this corporation is:

ITIEL COIN LAUNDRY, CORP.

# ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon filing.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting and conducting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

# ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of no par value common stock.

Shares may be issued for such consideration as is determined from time to time by the stockholders.

This power which is hereby reserved unto the stockholders by right may, and it is hereby delegated, unto the Board of Directors. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
