ARTICLES OF INCORPORATION
OF

CIGAR INTERNATIONAL, INC.

The undersigned subscribers to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the state of Florida.

ARTICLE I - NAME

The name of this corporation is CIGAR INTERNATIONAL, INC.

Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954, as amended.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is \$500.00.

This corporation is to exist perpetually.

ARTICLE XI - AMENDMENTS

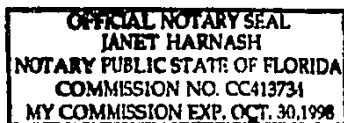
