CERTIFICATE OF INCORPORATION OF

"NORRIS & C. TRUCKING, INCORPORATED"

FIRST: The name of the Corporation is "NORRIS & C. TRUCKING, INCORPORATED."

SECOND: Its principal office in the State of Florida is to be located at 4500 North West 11TH. Street, in the City of Lauderhill, County of Broward.

THIRD: The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as any natural persons could or might do, in any part of the world, viz.:
