ARTICLE I - NAME

The name of this corporation is 3-D Trucking, Inc. The address for the corporation is 11733 Enterprise Drive, Port Richey, Florida 34668.

ARTICLE II - DURATION

This corporation shall exist for a perpetual period.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated.

ARTICLE IV - CAPITAL STOCK

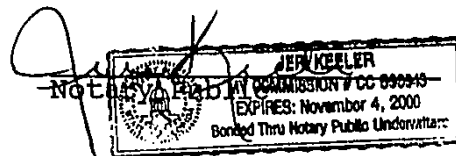

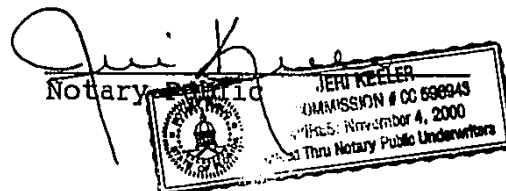
