ARTICLES OF INCORPORATION OF ANGEL PET, INC.



Pursuant to Chapter 607 Florida Statutes, the undersigned incorporator hereby adopts the following Articles of Incorporation:

- 1. The name of the corporation is ANGEL PET, INC.
- 2. The street address of the initial principal office and mailing address of the corporation are 3270 Torres Avenue, Pensacola, Florida 32503.
- 3. The number of shares the corporation is authorized to issue is 10,000.
- Each shareholder of this corporation shall have the first right to purchase shares (and any securities convertible to shares) of any class, kind, or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the price, terms and conditions of the issue of shares, and inviting them to exercise their preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
