The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE ONE:

NAME: The name of the corporation is: JOE DECKROW, INC.

ARTICLE TWO:

DURATION: This corporation shall exist perpetually.

ARTICLE THREE:

PURPOSE: This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR:

CAPITAL STOCK: The aggregate number of shares which the corporation has authority to issue is 500, all of which shall be common shares having a par value of \$1.00 per share.
