**ARTICLES OF INCORPORATION
OF
STORE 18, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is STORE 18, INC.

**ARTICLE TWO
Corporate Duration**

The duration of the corporation is perpetual.

**ARTICLE THREE
Purpose or Purposes**

The general purposes for which the corporation is organized are:

1. Lease and sale of real estate.
2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE FOUR
Capitalization**

The aggregate number of shares which the corporation is authorized to issue is 3000. 1000 shares belong to Aamir Waheed, 1000 shares belong to Tariq Waheed, and 1000 shares belong to Shawn C. Rokh. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE FIVE
Registered Office and Agent**

The street address of the initial registered office of the corporation is 314 Alexandra Woods, DeBary, Florida 32713, and the name of its initial registered agent at such address is AAMIR WAHEED. THE PRINCIPAL PLACE OF BUSINESS IS THE SAME AS THE REGISTERED OFFICE.

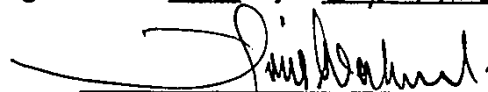

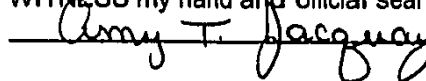
