

In compliance with the requirements of Florida Statute Chapter 607 and 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Professional Association, which elects to be treated as a corporation, for tax purposes, under subchapter "S" of the Federal Internal Revenue Code.

ARTICLE 1

The name of the Professional Association shall be Vangara & Vangara, P.A.

ARTICLE II

The existence of the Professional Association shall begin on the date of filing.

ARTICLE V

The maximum number of shares this Professional Association is authorized to issue is 1000, at initial value of \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

Only those persons who are physicians licensed to practice medicine in the state of Florida are eligible to become or remain shareholders of the Professional Association, and no ownership interest may pass, by whatever means, to a person who is not a physician licensed to practice medicine in the state of Florida.
