Vangara, M.D., being the sole Director, President and Secretary, of VANGARA & VANGARA, P.A., does hereby certify that the following Amendment to the Articles of Incorporation of VANGARA & VANGARA, P.A. was approved by the Stockholders of said Corporation on the 4th day of January, 1999, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of VANGARA & VANGARA, P.A. are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

**ARTICLE I**

2.
