ARTICLE I

NAME

The name of this corporation is Christopher A. White, P.A. and the principal place of business is 436 Jacksonville Drive, Jacksonville Beach, Florida 32250.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of and engaging and transacting any and all lawful business permitted under the laws of the State of Florida or any other state and of the United States. The specific nature of the business is to provide legal services to the public.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue five hundred (500) shares of common stock having a par value of One and no/100 Dollar (\$1.00) per share, which shares shall be and hereby are designated as common shares. Without action by the stockholders, any or all of the authorized shares may be issued by the corporation from time to time for such consideration as may be fixed by the Board of Directors of this corporation.

ARTICLE IV

TERMS OF EXISTENCE

The term for which this corporation shall exist shall be perpetual, commencing on the date of filing these Articles.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

The initial registered agent of this corporation in the State of Florida is 436 Jacksonville Drive, Jacksonville Beach, Florida 32250, and the name of the initial registered agent of this corporation at that address is Christopher A. White. The Board of Directors may, from time to time, change the registered agent or move the registered office to any other address in Florida.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or diminished, from time to time, by amendment to the Bylaws, but in no event shall the number of directors be reduced below one (1). BYLAWS



AMENDMENTS

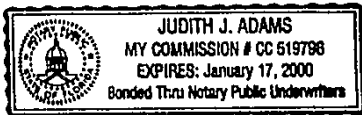




