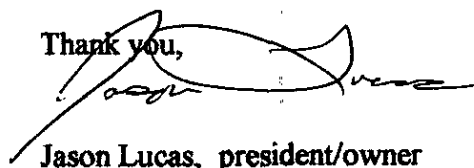
To whom it may concern;

Enclosed is the \$150.00 corporation filing fee. We called (850) 487-6050 on 4-21-00 at 2:55 PM to send us papers and to dissolve our corporation. We received the papers in the mail several days later and sent in the completed form and \$43.75 check # 129 on 4-30-00. Since we we're planning on dissolving our corporation the end of April, we did not pay the \$150.00 corporation filing fee that is normally due by May 1, 2000 since it would not be necessary.
