## ARTICLES OF INCORPORATION

**OF** 

## WINNIE & Winnie, P.A.

THE UNDERSIGNED acting as the sole incorporator of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the Corporation (the "Corporation") is WINNIE & WINNIE P.A.

SECOND: The purpose or purposes for which the Corporation is organized the professional Association of Attorneys providing legal services in the State of Florida and elsewhere and to engage in the transaction of any other lawful business for which professional corporations may do while so incorporated under the provisions of the Florida General Corporation Act.

THIRD: The aggregate number of shares which the Corporation shall have authority to issue is one hundred(100) shares of common stock at no par value.
