ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be J. B. DRAIN SERVICE, INC., and its principal place of business shall be at 6980 Big Bend Drive, St. Cloud, FL 34771, but it may establish branch offices at other points deemed advisable by its Board of Directors within the State of Florida.

ARTICLE II

The purpose or purposes for which the corporation is organized is the business of drain cleaning and chemical services and to engage or transact in any and all lawful activities or business and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by any other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE III

This corporation shall have a perpetual existence.

#### ARTICLE IV

The business of the corporation shall be conducted by officers to be named by a Board of Directors of three (3) or more members; but the number of Directors may be increased or decreased from time to time by the By-Laws of the company or by resolution of the Stockholders at any annual or special meeting.

Other offices may, in the same manner, be abolished or created, established and filled.

Any number of such offices may be held and filled by one and the same person.

All officers shall be elected by the Directors.

The Directors shall be elected by the Stockholders at each annual meeting of the Stockholders which shall be held on the second Tuesday in the first month immediately following the tax year of the incorporation, but the date of such annual meeting may be changed by the By-Laws or by Resolution adopted at any meeting of the Board of Directors or by Stockholders at any annual or special meeting.

#### ARTICLE V

The Directors shall meet to adopt By-Laws, and until their successors shall have been elected or appointed and qualified, the business of the corporation shall be conducted by the following Board of Directors and Officers: Joseph Franklyn Bowling, President and Director  
Paul F. C. Bowling, Vice-President and Director  
Marion Bowling, Secretary-Treasurer and Director

#### ARTICLE VI


There shall be issued one thousand (1,000) shares of capital stock, which shall have a par value of \$1.00 per share. All stock shall be nonassessable, payable in lawful money of the United States of America, or in property, labor, or services at a just valuation to be fixed by the Director(s) of the corporation at the organizational meeting held after the granting of the charter herein applied for.

The capital stock of the company shall be sold, signed, issued and transferred only in accordance with the By-Laws.

ARTICLE VII


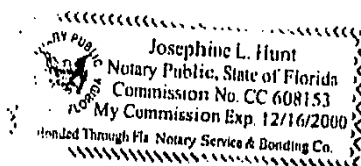

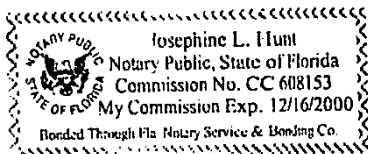
