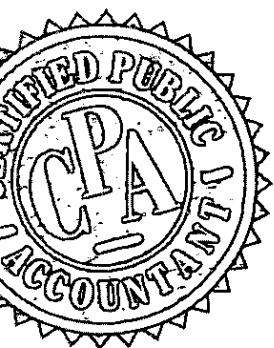

Ladies and Gentlemen:

I am writing on behalf of South Florida Moving Systems, Inc. I recently finished preparing tax returns for my client and, in performing a routine check of Florida DOS web site, I was disturbed to learn that this company had been administratively dissolved on 09/22/2000 due to the non-receipt of the 2000 Annual Report.

I advised Matthew Shiver, President of the company, of the dissolution and the circumstances which precipitated the action, i.e., not returning the 2000 Uniform Business Report (UBR) with appropriate payment. He was fairly upset and clearly vocalized that he did not receive the UBR in 2000. He further stated that his Mailing Address, viz, 5200 N. Federal Hwy, #2-1079 in Deerfield Beach was a MailboxEtc.. location and that he has had numerous situations where he has not received mail intended for South Florida Moving Systems.

He asked me why he had not received any notice to the corporation's Registered Agent address which of course is also on file. I explained that the Division's normal procedure is to mail the UBR and any subsequent late filing notice to the Principal Address rather than the Registered Agent's address.

I will say that Mr. Shiver is a very honest, hardworking individual who considers his tax and reporting compliance very seriously. In my opinion, Mr. Shiver would have responded promptly to any notice from the Division if he had simply received it.

Accordingly, Mr. Shiver is respectfully requesting the reinstatement of his corporation to that of active status. Mr. Shiver is also requesting a waiver of the \$600 late fee on the basis that he did not receive the 2000 UBR nor did he receive any other notification at the Registered Agent address. In order to avoid any future instance of not receiving the UBR Mr. Shiver is changing the Mailing Address to his home address, or that of Registered Agent.

Please find enclosed a completed Corporation Reinstatement form along with the corporation's check, #6722 in the amount of \$450, to be applied to the three prior years' (2000, 2001 and 2002) fees at the rate of \$150 per year.
