**ARTICLES OF INCORPORATION
OF

Initial Director

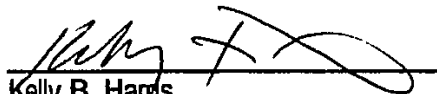
The corporation shall have two directors who shall manage the corporation. The initial directors shall be Kelly B. Harris and Martin R. Harris.

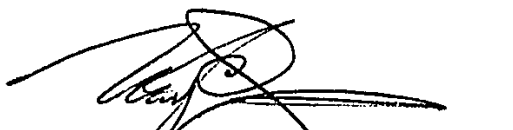
