**ARTICLES OF INCORPORATION  
OF  
N & G TRANSPORT SERVICE, INC.**

The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

**ARTICLE I NAME**

The name of the Corporation is N & G Transport Service, Inc.

**ARTICLE II PRINCIPLE OFFICE**

The principal office of the Corporation is at 7815 Social Circle #D Tampa, fl., 33614 in Hillsbrough County, State of Florida.

**ARTICLE III REGISTERED AGENT**

**ARTICLE IV BOARD OF DIRECTORS**

#### **ARTICLE VI DURATION**

The Corporation shall have perpetual existence.

#### **ARTICLE VI PURPOSES**

The purpose for which this Corporation is organized is to engage in any and all lawful business

#### **ARTICLE VIII POWERS**

The Corporation may exercise any powers, without limitation whatsoever, which a Corporation may legally exercise under the laws of the State of Florida where this Corporation is formed. In addition, the Corporation shall have the following specific powers:

- ( A ) To elect or appoint officers and agents of the Corporation and to fix their compensation;
- ( B ) To act as an agent for any individual, association, partnership, corporation or other legal entity;
- ( C ) To receive, acquire, hold, exercise rights arising out of the ownership or possession thereof, sell, or otherwise dispose of, shares or other interests in, or obligations of, individuals, associations, partnerships, corporations, or governments;
- ( D ) To receive, acquire, hold, pledge, transfer, or otherwise dispose of shares of the corporation;
- ( E ) To make gifts or contributions for the public welfare or for charitable, scientific or educational purposes.

#### **ARTICLE IX CAPITAL STOCK**

Section 1. Authorized shares. The total number of shares which this Corporation is authorized to issue is One Hundred (100)

Section 2. Preemptive rights. Except as may otherwise be provided by the board of directors, no holder of any shares of the stock of the corporation shall have any preemptive right to purchase, subscribe for, or otherwise acquire any shares of stock of the Corporation of any class now or hereafter authorized, or any securities exchangeable for or convertible into such shares, or any warrants or other instruments evidencing rights or options to subscribe for, purchase or otherwise acquire such shares.

## ARTICLE X COMMENCEMENT OF BUSINESS

The minimum amount of capital with which the Corporation will commence business is One Thousand dollars (\$1,000.00)

## ARTICLE XI INTERESTED DIRECTOS

No contract or transaction between this Corporation and any of its directors, or between this Corporation and any of its directos, or between this Corporation and any other corporation, firm, association, or other legal entity shall be invalidated by reason of the fact that the director of the Corporation has a direct or indirect interest, pecuniary or otherwise, in such corporation, firm, association, or legal entity, or because the interested director was present at the meeting of the Board of Directors which acted upon or in reference to such contract or transaction, or because they participated in such actions, provided that the interest of each such director shall have been disclosed to or known by the Board and a disinterested majority of the board shall have nonetheless ratified and approved such contract and transaction. Such interested director or directors may be counted in determining whether a quorum is present for the meeting at which such ratification of approval is given. If the interest of such director or directors, is, or was, necessary for the approval of such contract or transaction, then such contract or transaction shall, with disclosure of the director's or director's interest, be submitted for the approval of or ratification by the stockholders.
