The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE 1. NAME: The name of this corporation is

ARTICLE 2. DURATION: The term of existence of the Corporation is  
perpetual.

ARTICLE 3. PURPOSE: This Corporation is organized for the purpose of
