ARTICLE I. NAME

The name of this corporation is:

ARTICLE II. DURATION

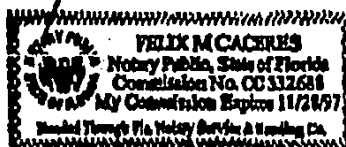

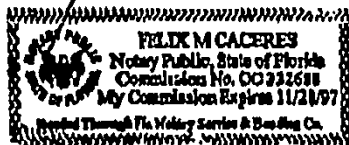
