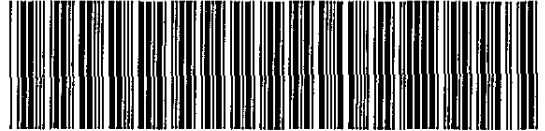

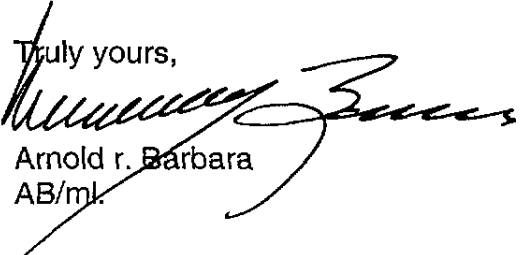

FIRST: Amendment adopted: Article I - Amend the corporate name to:

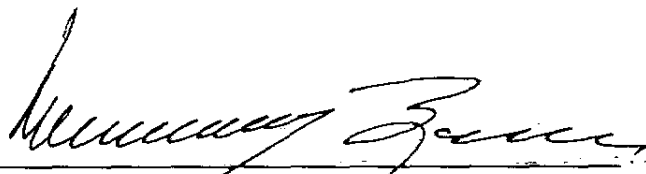
Arnold Barbara & Associates, P.A.
