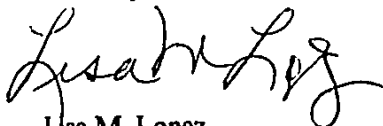

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Article of Incorporation:

**ARTICLE I  
NAME OF BUSINESS**

The name of the corporation is OFFICE SERVICES OF SOUTH FLORIDA, INC., and its office is located in 4445 West 16th Avenue, Suite 406, Hialeah, Florida

**ARTICLE II  
NATURE OF BUSINESS**

The general nature of business of the corporation and the objects and purposes to be transacted, promoted or carried on by it are as follows: The transaction of any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE III  
CAPITAL STOCK**

The maximum number of shares of stock which the corporation is authorized to have outstanding at any one time shall be One Hundred (500) shares of common stock, having a par value of One Dollar (\$1.00) each, amounting in the aggregate to Five Hundred (\$500.00) Dollars. All shares be of one class and shall be designated as Common Stock. Any and all such shares shall not be liable for any further call or assessment or any other payment thereon.

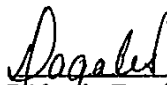

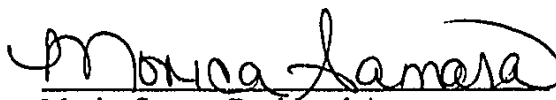
