### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the corporation is L & M Graphics, Incorporated.

#### ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is September 30, 1997.

#### ARTICLE THREE

The general purposes for which the corporation is organized are:

Incorporation as originally filed or by any amendment thereof or out of shares or the corporation acquired by it after the issuance thereof, and whether issued for cash, labor done, personal property or leases thereof: or

2. Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock or the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.

#### ARTICLE NINE

The affirmative vote of all of the shares of the corporation represented at a meeting at which a quorum is present shall be required to amend these Articles so as to increase or decrease the authorized number of, or change the designations, preferences, qualifications, limitations, restrictions, or special or relative rights of any of the various classes of shares: or to merge or consolidate the corporation with or into any other corporation, or sell, lease, or convey all or substantially all of the assets of the corporation, or voluntarily to dissolve, liquidate or wind up its affairs.


