The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I <u>Name</u>

<u>Section 1.1</u>. <u>Name</u>. The name of this corporation shall be Hartje Biofeedback Training, Inc.

Article II Principal Office and Mailing Address
