1. Name. The name of the corporation is: HARVEY R. LANGE, JR., M.D., P.A.
2. Purpose. The corporation may engage in the business of carrying on a practice of medicine and rendering professional medical services; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on October, 1, 1997.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 6500 Newberry Road, Gainesville, FL 32614 and the name of its initial registered agent at such address is Harvey R. Lange, Jr., M.D.

7. Management. Business of the corporation shall be managed by the stockholder.
