The undersigned hereby adopts the following Articles of Incorporation for the purpose of formula (DA) a corporation under the laws of the State of Florida:

#### **ARTICLE I - Name**

The name of the Corporation is CUSTOMER COMES FIRST, INC.

#### **ARTICLE II - Commencement and Duration**

The Corporation is to commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

#### **ARTICLE III - Purpose**

The Corporation is organized for the purpose of transacting any and all lawful business.

#### **ARTICLE IV - Principal Office**
