THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY FORMS A CORPORATION UNDER THE LAWS OF OF STATE OF FLORIDA.

ARTICLE I. NAME

THE NAME OF THE CORPORATION IS PROFESSIONAL TOUR GUIDES, TRAVEL & TRANSPORTATION, CORP.

ARTICLE II. ADDRESS


