**ARTICLES OF INCORPORATION  
OF

**KNOW ALL MEN BY THESE PRESENTS:** That the undersigned incorporator does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation shall be and is DALE LAW FIRM, P.A.

**ARTICLE II**

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the time these Articles of Incorporation are filed by the Department of State of the State of Florida.

**ARTICLE III**

The general purpose for which the corporation is initially organized are as follows:

- (a) To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes; and
- (b) To engage in the practice of law. In addition with the above-mentioned purpose, the corporation may do any legal act that any other type of corporation may do under the laws of the State of Florida, except as is limited by Chapter 621, Florida Statutes (1993).


