hereby forms a corporation under the laws of the State of Florida

as follows:

#### ARTICLE I.

## Name

The name of this corporation is WURZBURG BOCA GREENS, INC.

#### ARTICLE II.

## Term of Existence

## Nature of Business

# Powers
