#### ARTICLES OF INCORPORATION OF

# Manso Services, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms corporation under the laws of the State of Florida.

# ARTICLE I NAME

The name of the corporation shall be Manso Services, Inc.

### ARTICLE II NATURE OF BUSINESS

The foregoing right of indemnification shall be inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.

firm, association or corporation in which he may be in any way interested. Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
