(A Florida Corporation)

The undersigned hereby petition for the formation of a corporation under the laws of the State of Florida, with and under the following charter:

ARTICLE I

The name of this corporation shall be ALERT MINI BUS SERVICE INC.

ARTICLE II

The general nature of the business to be transacted shall be sale and rental of real estate and to otherwise engage in any activity or business permitted under the Laws of the United States of America and this State.
