ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is BON AD, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

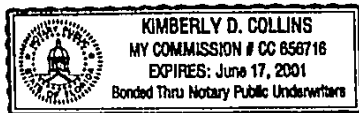


