
To Whom it May Concern:



### ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the Corporation shall be Seven Gardens Landscape Co.
2. The principal office and mailing address of the Corporation shall be 820 NW 10th Ave., Gainesville, FL 32601.
3. The number of shares of common stock that the Corporation shall be authorized to have outstanding at any one time is 100,000 in one class only.
4. The initial registered agent of the Corporation shall be Steven Greenough and the registered address shall be 820 NW 10th Ave., Gainesville, FL 32601.
5. The incorporator to these Articles of Incorporation is Steven Greenough, whose address is 820 NW 10th Ave., Gainesville, FL 32601.
6. The initial Board of Directors of the Corporation shall consist of one member only whose name and address is Steven Greenough, 820 NW 10th Ave., Gainesville, FL 32601. The number of directors of the Corporation may be raised or lowered by amendment of the bylaws but in no case shall be less than one. Directors shall be chosen in accordance with the bylaws of the Corporation.
7. The purpose of the Corporation shall be to provide comprehensive landscape services to the public. The Corporation may also engage in any other lawful business.
8. The effective date of this incorporation shall be October 1, 1997.


