ARTICLES OF INCORPORATION OF CARON MCGINLEY, P.A.

The undersigned incorporator, for the purpose of forming a Professional Association under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Professional Association is: CARON McGINLEY, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be: 132 N.W. 10th Court, Boca Raton, FL 33486.

ARTICLE III - PURPOSE

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 500 shares of Common Stock, for a nominal or per value of \$1,00 per share.
