ARTICLE II. NATURE OF BUSINESS

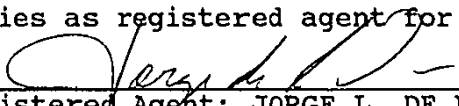

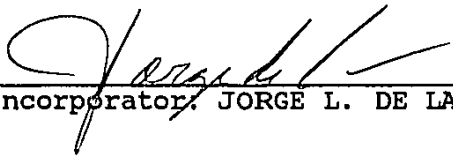

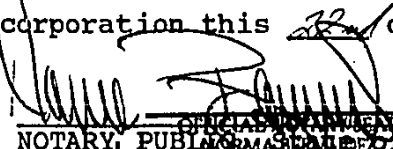
