ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of **VISA CAPITAL CORP.**, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is VISA CAPITAL CORP.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

ARTICLE VII. INCORPORATOR

The name and street address of the incorporators are Vicente Sanchez and Maria Isabel Sanchez, 914 Alfonso Avenue, Coral Gables, Florida 33146.

The incorporators of the corporation assigns to this corporation their rights under Section 607.0201, Florida Statutes, to constitute a corporation, and they assigns to those persons designated by the board of directors any rights they may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.

ARTICLE VIII. BYLAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

ARTICLE IX. AMENDMENTS
