NAME

The name of this corporation shall be **J & L ENTERPRISES OF SOUTH FLORIDA, INC.**

ARTICLE 2.

EFFECTIVE DATE and DURATION

This corporation shall be effective October 1, 1997. This corporation shall have perpetual existence.

ARTICLE 3.

CAPITAL STOCK
