The undersigned subscriber to these articles of incorporation, being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

Gandy Glass Company, Inc. is the name of this corporation.

ARTICLE II. PRINCIPAL OFFICE

The Principal office of the corporation is 2291 Highway 92 East, Plant City, Florida 33566.

ARTICLE III. DURATION

This corporation shall have perpetual existence and shall commence October 1, 1997.

ARTICLE IV. PURPOSE



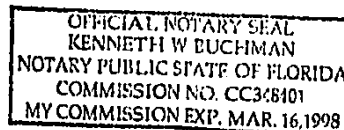


